Public Works Committee Chairman Kilgore mentioned the Firewise program Mayor Scherer allowed Councilmen Kilgore to meet with DNR Public Works Committee Chairman Kilgore would like to look at Cloud Backup, IT services- like to know what it costs

Councilmember Long has a Presentation in Olympia on August 9 and a meeting with Rep. Dent and Warnick on Aug. 30

Councilmember Gray: wheeled ATV use- revisit or put up signs- possible change speed limits when entering town, paint 25 on the street.

Councilmembers Long and Gruber agreed to move the speed limit signs Mayor Scherer said he would talk to DOT.
