#### 7.) AB17-071 Penn Ave Pedestrian Improvement Project 60%

4 replacement lights, 7 pedestrian lights on existing poles, smoke colored concrete

Chris Martin- lamp black is historic in concrete, recommends not changing good concrete out, Save costs on pedestrian lighting

Christina- Perteet: no proposed changes to Basecamp structure/ Prisms will stay

Chris asked if crews can work 12-24 hour shifts to get the project done sooner.

Laura Osoadacz 310 1st st asked if there is a way to have the sidewalks salvaged?

Christina said better to remove, curb line, pedestrian safety and help with drainage

Councilmember Long said he respect what impact the project will have but in return it will have great benefits

Councilmember Januszkiewicz added it will be good for all sidewalks to be on the same schedule

Dustin Auckland 704 S A St asked if all of Pennsylvania Ave will be 100% ADA

Christina-Perteet said yes/ the parts that are in the project
