Clerk Taklo told the entering Administration Committee that the Mayor, Councilmember Kilgore and Staff were looking at Option C

Councilmember Kilgore said during the Public Works Committee there were no decisions made nor actual suggestions

## Changes to be made to the budget:

-\$3000.00 Comp Plan (\$35-\$32k)

Ok \$550,000 001 Fund

Think about reinstating the Park Fee

-\$3000.00 Playground

\$5000.00 to \$1500. In Cemetery Facility Maintenance, 1-250 Misc. and 2-1 Cemetery Restoration

-\$500 (\$15-10) in Street Maintenance- Contracted Services

Councilmember Kilgore asked Treasurer Graham- Option A & B presumable includes extras that got cut

Treasurer Graham said A, B and C Options are different staffing options

Treasurer Graham said she was working off of Option A, Council said they were working off of Option C (Clerk Taklo told them that was what the Mayor was looking at)

Treasurer Graham said yes the Mayor was looking at C but she was working off of A

- Salaries were the only change between A, B and C option.
- The \$12,000. reduction was based off of Option A
- Option A was the only version they had been provided previously

Councilmember Cooke recommends moving forward with Option A, others agreed
