CALL TO ORDER, FLAG SALUTE, ROLL CALL, AGENDA UPDATE:

3.) Citizens Advisory Committee Winter Recreation Presentation Melissa Speeg gave a presentation.

Councilmember Cooke talked about the Cities Comp plan. Councilmember Adams thinks the CAC is on the right track however enforcement is the biggest issue and he feels there needs to be more signage on the backside of the RUF. Melissa said she'd also like to see more way finding signs. Councilmember Weis doesn't think there is access on Alliance road. He does like the idea of Alaska Alley.

Councilmember Weis also feels strongly that the Council, Commission's and Committees need to quit saying No to everything, we need to figure out how to make things work. He also added that the CAC should talk to other neighboring property owners such as the Olsen's or Inland not just Baxter State Park. Councilmember Spurrier feels staying out of the RUF is the best option. Councilmember Cooke added that motorized and walking don't mix well.
