WHEREAS, Roslyn Municipal Code Section 1.04.110 allows the Roslyn City Council to set fees by Resolution of the City Council; and


WHEREAS, City Staff has performed a review of the current fee schedule and added fees that were previously under review or missing;

Section 2. Resolution 11-066 is hereby rescinded



LEGEND/NOTES

1. + Costs: In addition to the base application fee the Applicant shall reimburse the City for the costs of required legal notices, professional engineers, and other consultants retained by the City to review and inspect the Applicant's proposal not covered by the base fee. These professional services may include, but are not limited to: engineering, traffic engineering, legal, planning, environmental review, financial, accounting, utility locations, soils, mechanical and structural engineering. In the event that a project requires special analysis by City Staff beyond that which is included in the base fee, the Applicant shall also reimburse the City at a rate of \$50 per hour for this extra staff time. The City may require the Applicant to deposit an amount with the City to cover anticipated costs of retaining professional consultants or performing special staff analysis prior to initiating a review of the proposed project.
2. The reference to IBC Fees, means that the fees shall be calculated in accordance with the provisions of the International Building Code as adopted by the City of Roslyn.
3. Business License fees are based on the number of employees in accordance with the provisions of the Business License Program.
4. Copy fees are for public records requests only and shall not be construed to mean that the general public will be allowed to use City equipment to make general copies.
5. The City may also require financial guarantees and/or performance bonds to ensure the timely completion and satisfactory completion and maintenance of project related activities.
6. This fee schedule shall not preclude the City from imposing mitigation fees and/or entering into voluntary mitigation fee agreements through the exercise of its substantive SEPA authority.
7. If a permit category is not listed, then the Mayor or his/her designee shall determine the fee schedule for that category.
8. In the event of unique and unusual circumstances, community fund raising events, and/or economic hardship the Mayor may waive or reduce a fee.
